**10. Technical Requirements:** Purchaser shall provide sound and/or lighting equipment as described in the attached Technical Rider. Purchaser shall provide a copy of the Technical Rider to the sound and lighting technicians no less than two (2) weeks prior to the engagement.

### 11.0 Cancellation:

**11.1** Purchaser agrees that Artist shall have the right to cancel this engagement without liability upon written notice to Purchaser no later than 10 days prior to the date of performance in the event Artist is called upon to render their services for a radio or television appearance, motion picture, or any career advancing opportunity. Artist will attempt to reschedule the date with the Purchaser for a mutually convenient time.

**11.2** Should Purchaser have cause to cancel this agreement, notice must be given to Artist in writing no later than thirty (30) days prior to this engagement. Any notice given less than thirty (30) days will require full payment by Purchaser to Artist as described in Contract paragraph 5.4 unless Artist agrees to waive any part of that payment or Purchaser and Artist agree to reschedule the engagement for another time.

**12. Force Majeure:** This agreement by both parties to perform their obligations herein is subject to proven detention by serious illness, accidents, or accidents to means of transportation, labor disputes or walkouts, acts of God, or any act of public authority, material breach of Contract by Purchaser, or any other condition beyond either party's control. Neither party shall be liable to fulfill the remainder of the Contract nor perform or present any "make-up" date unless expressly agreed to by both parties for a convenient future time.

**13. Disputes and Attorney's Fees:** Any controversy or claim arising out of or relating to this Contract, or the breach thereof, shall be settled by arbitration administered by the American Arbitration Association in accordance with its [applicable] rules and judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction thereof.

14. It is agreed that Artist signs this agreement as an independent contractor and not as an employee.
